It is notified for the information of all concerned that:

01. The interview of all the eligible shortlisted candidates shown in Annexure "A" to this notification, who have applied for the posts of Fisheries Guard and Chowkidar (District Cadre) in District Kulgam, Fisheries Department in reference to the Advertisement Notification No. 02- Fisheries of 2015 dated: 10-09-2015, shall be conducted on 11-08-2017, in the office of the undersigned at District Office Mini Secretariat Kulgam (Room NO.243) from 10:30 A.M onwards.

02. The criteria and the eligibility of the selection for these posts is as under:

Weightage to basic qualification	Weightage to higher prescribed qualification	Viva Voce	Total Points
i.e. Matric 60 points	H. S. Part II (10+2) 20 points	20 points	100 points

03. The Weightage has been calculated on *prorata* basis with reference to the %age of marks obtained in the prescribed qualification/ examination as per the formula (%age multiplied by total points for a particular qualification divided by 100).

04. The candidates shown in Annexure "A" has been shortlisted in terms of 1:5 ratio in each category. The cut-off points for these posts is as follows:



05. In case of the candidates whose names do not figure in the shortlist and have got points more than or equal to cut off points may submit their claim on application along with all supporting / authenticated documents by or before 06-08-2017 for consideration on merits and thereafter no claim shall be entertained.
06. Mere figuring of the name in the Short List does not entitle the candidate to appear in the interview as it shall be subject to the scrutiny of all testimonials of the candidate shortlisted.
07. No interview call letter shall be issued separately.
08. The prescribed qualification /reserved category certificate acquired by the candidate after the last date of receipt of application forms shall not be entertained.
09. The candidates shall have to produce all original certificates/ testimonials at the time of interview. The candidates failing to produce such certificates /testimonials may forfeit their candidature and will not be allowed to appear in the interview.
10. Any candidate found guilty of impersonating or submitting fabricated /tampered documents or making false, incorrect or suppressing material information shall render him/ her liable for criminal prosecution under law. Also canvassing/ lobbying in any form will entail disqualification of the candidate.
11. No TA/DA shall be paid for participation in the interview.
12. Failure of a candidate to appear in the interview on the above given notified date shall not be entertained later and shall forfeit his /her right of consideration.

Note:- The candidates are advised to bring Photostat copy of each certificate duly attested by a Gazetted officer with his / her seal and signature and self signed by the candidate itself for depositing with the Selection Committee at the time of interview in addition to original documents.
